This is a summary of the annual report for LOCAL 282 JOB TRAINING TRUST FUND, EIN 11-6399999, Plan Number 503, for the period January 1, 2023 to December 31, 2023. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BOARD OF TRUSTEES LOCAL 282 has committed itself to pay the following types of claims incurred under the terms of the plan:

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$2,018,107 as of December 31, 2023, compared to \$1,868,896 as of January 1, 2023. During the plan year the plan experienced a change in its net assets of \$149,211. The plan had total income of \$681,666 which included employer contributions of \$521,999, employee contributions of \$0, gain/loss of \$0 from the sale of assets, and earnings from investments of \$159,667

Total plan expenses were \$532,455. These expenses included \$230,670 in administrative expenses and \$301,785 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
